2. Resolution #1 – Partnership with Steve Whitesell for Pratt Rock Park Phase A

Whereas, the Town of Prattsville will enter into a partnership agreement with Steve Whitesell in the administration of the Pratt Rock Phase A Capital Project.

Whereas, Under the terms of this partnership, Steve Whitesell will act as the board's consultant, with responsibilities including the following:

- Ensuring the quality of the final product through site inspections
- Reviewing submittals by the Prime Contractor
- Verifying pay item quantities prior to submitting to the board
- Submit to the board, in writing, any requests to exceed contract quantity or approve additional funding

Whereas, the Town of Prattsville will compensate Steve Whitesell the lump sum amount of \$5000 to be paid upon the satisfactory and substantial completion of contract work;

Whereas, the Town Board reserves the right to terminate this agreement prior to its expiration in the event of a failure to fulfill the responsibilities outlined herein.

3. Resolution #2 – Awarding a Bid to Evergreen Mountain Contractors to Provide Hiking Trail Enhancements at the Pratt Rock Park Located in Prattsville, New York.

WHEREAS, part of the work to be performed in the provision of enhancements to the hiking trails located at the Park,

WHEREAS, the Town Board has advertised for and has received 3 bid(s) for the work to be performed; and

RESOLVED, the Town Board finds Contractor Evergreen Mountain Contractors to be the lowest and responsive bidder to provide hiking trail enhancements to the Pratt Rock Park at a bid of \$174,750.00 and hereby awards the contract for the work to be performed to them; and be it further

RESOLVED, that the Supervisor is authorized to sign an Agreement with Contractor Evergreen Mountain Contractors at the price listed above.

WHEREAS, the Town and the Prattsville Water District (the Water District) have undertaken a new Well Project (the Project) to improve and ensure well protection within the Town; and

WHEREAS, the Project requires certain transfers of real property, specifically, a fee parcel, an easement for wellhead protection, and an easement for maintenance at property located Washington Street Ext., in the Town of Prattsville, NY, more specifically described as Parcel Number 74.14-1-40, 74.14-1.19, 74.14-1-20.2, 74.14-1-21, 74.14-1-22, 74.14-1-37, 74.14-1-38 (the Property), to the Town and the Water District; and

WHEREAS, the Town and the Water District have jointly contracted with James A. Young and Peggy A. Young, John J. Young, James A. Young And Arthur J. Young & Son, INC as owners of the Property, to obtain said fee parcel and easements; and

WHEREAS, it is desired by both the Town and the Water District that all closing documents associated with these real property transfers be signed by the Town Supervisor.

RESOLVED, that the Town Board hereby authorizes the Supervisor to sign all closing documents on behalf of the Town and the Water District as it relates to the real property transfer of a fee parcel, an easement for wellhead protection, and an easement for maintenance at property located Washington Street Ext., in the Town of Prattsville, NY, more specifically described as Parcel Number 74.14-1-40, 74.14-1-38 from James A. Young and Peggy A. Young, 74.14-1-19, 74.14-1-21 from John J Young, 74.14-1-20.2, 74.14-1-22 from Arthur J Young & Son, INC and 74.14-1-37 from James A. Young to the Town and the Prattsville Water District for the new Well Project.

5. There have been a few requests regarding headstones that have been knocked over at the cemetery. Looking ahead, Supervisor Cross would like to discuss including a dedicated line item in the budget to address similar repairs in the future.
